

Annual Governance Statement for the Local Governing Board (LGB) of Litcham school. September 2024

The Local Governing Body of Litcham school has a strong focus on its core strategic functions:

The work that we have done within the governor board

There are no committees within the governor board, however all governors are involved in different links. All governors are able to report back to the LGB at any time and contribute to all discussion and decisions made. They are also able to ask for an agenda item to be included at any meeting. Safeguarding has been regularly and accurately followed by our governor responsible for safeguarding. Subject-lead staff and other senior leaders attend meetings to provide an overview of their subject or key area on a regular basis.

The governor body has continued to be actively involved in monitoring school improvement.

Governors regularly discuss data giving the results of pupil achievements and progress, so that we can be sure that the school is on track to fulfil its targets for all pupils.

Governors note the receipt of policies approved by the Trust and where appropriate local information is added.

The pupil admission number is 25 for Reception and 87 for Year 7.

Although the LGB is not responsible for the finance, the LGB continue to receive reports on the financial status of the school.

Minutes of the LGB meeting are public documents and can be requested via the school office.
